Equipment Recommendation

• Cee-Bee[®] E-1092T may be contained in tanks fabricated of 300 series stainless steel, polypropylene or polyethylene.

Paint Removal and Softening

- 1. Completely immerse parts in remover. Use undiluted at ambient temperature and soak until the coating is loosened.
- 2. When the coating is satisfactorily loosened (1 hour to overnight), withdraw the parts and drain over the tank.
- 3. Remove loosened paint with high pressure, air-boosted water. Removal may be assisted by agitating the surface with stiff bristle brushes.
- 4. Re-immerse parts in the tank to remove residual paints adhering to the surface. If residues are not removed after a suitable dwell time, an appropriate media blast procedure can be employed.

NOTE:

• Bath life can be extended by keeping the tank covered and by periodic de-sludging to remove paint residues.
