## Notes Prior to Handling

#### <u>Dip Tank</u>

- 1. Immerse parts in undiluted Cee-Bee<sup>®</sup> WDO at ambient temperature. The water displaced by the preferential wetting action of Cee-Bee<sup>®</sup> WDO will settle at the bottom of the tank.
- 2. After about 10 to 60 seconds, remove the parts and allow excess Cee-Bee<sup>®</sup> WDO to drain back into the tank.
- 3. Air dry.

#### Note:

- Tanks containing Cee-Bee<sup>®</sup> WDO should be equipped with a drain on or near the bottom of the tank to facilitate draining of immiscible water.
- Water, collected as an immiscible layer on the bottom of the tank, should be periodically drained off and fresh Cee-Bee<sup>®</sup> WDO added to raise the volume.

#### Spray-On

- 1. Spray on undiluted Cee-Bee<sup>®</sup> WDO at ambient temperature using non-atomizing spray equipment. Thoroughly wet the entire surface.
- 2. Allow parts to air dry.

#### **Removal of Cee-Bee® WDO**

• Cee-Bee<sup>®</sup> C-50 wipe solvent, Cee-Bee<sup>®</sup> Cleaner R-679 solvent/emulsion cleaner, or Cee-Bee<sup>®</sup> A-7X7 or Super Bee<sup>™</sup> 300LF/G hot tank cleaner can be used to remove the Cee-Bee<sup>®</sup> WDO protective film.

## Safety, Handling, and Precautions
