Use Procedure

Recommended Dilution Ratios

Heavy greasy soils & light CIC: Use Super Bee™ 262 Clear Gel undiluted. Will cling to surfaces. Moderate to heavy soils: Mix 1-part Super Bee™ 262 Clear Gel with 2 to 10 parts water. Light to moderate soils: Mix 1-part Super Bee™ 262 Clear Gel with 10 to 20 parts water.

Use Procedure Including Water Rinse

- 1. Apply Super Bee™ 262 Clear Gel with mops, brushes or non-atomizing spray equipment. Start at the bottom of the surface to be cleaned and work upward to avoid streaking.
- 2. Allow the cleaner to dwell at least 5 minutes until soils are penetrated, then agitate surface with a brush or mop.
- 3. Rinse thoroughly with high pressure water, starting at the top and working downward. Best results are obtained if the water is approximately 140°F (60°C).

Use Procedure Without Water Rinse

- 1. Saturate rags or mops with Super Bee™ 262 Clear Gel and wipe the surface to loosen the soils.
- 2. Remove loosened soils with clean, dry rags or mops, turning frequently to avoid re-deposition of soils.



Safety, Handling, and Precautions

- Irritating to eyes and skin. Avoid contact.
- In case of accidental contact, flush thoroughly with water. If irritation persists, seek medical attention.
- Do not take internally.
